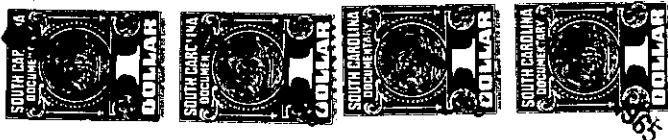

ALL that lot of land with the buildings and improvements thereon, situate on the North side of Randall Street, in the City of Greenville, in Greenville County, South Carolina, being shown as a portion of Lot 23 of Section "A" on plat of Stone Land Company, recorded in the RMC Office for Greenville County, S.
