All that lot of land in the city of Mauldin, Greenville County, state of South Carolina, and having according to a survey made by C. O. Riddle, Engr., March 16, 1965, recorded in plat book III, page 49 of the RMC Office for Greenville County, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the south side of Sunrise Drive, corner of property of Jim Willis Whitt, and running thence with the line of said property S. 25-03 E. 282.8 feet to an iron pin in line of Mauldin School property; thence with the line of said property N. 60-15 E. 50 feet to an iron pin corner of Chastain property; thence with the line of said property N. 20-16 W. 285.3 feet to an iron pin on the south side of Sunrise Drive; thence with the south side of said street S. 60-44 W. 73.6 feet to the beginning corner.
