That we, V. W. SWAN and JIM SWAN in consideration of the sum of Two Hundred Fifty and No/100 (\$250.00)----- DOLLARS,

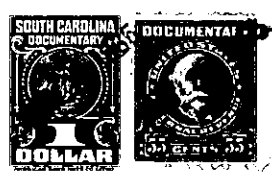
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said IVAH MAE SIMPSON and BEULAH S. BATES, Their Heirs and Assigns, Forever:

ALL that lot of land situate on the North side of Hagood Road, in Cleveland Township, Greenville County, South Carolina, being shown as Lot No. 221 on Map #2 of Pioneer Park, made by Dalton & Neves, March 1926, revised June 1926, recorded in the RMC Office for Greenville County, S. C., in Plat Book G, Page 82, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Hagood Road at the joint front corner of Lots 220 and 221 and runs thence along the line of Lot 220, N. 2-48 W., 150 feet to an iron pin; thence N. 87-12 E., 100 feet to an iron pin; thence along the line of Lot 222, S. 2-48 E., 150 feet to an iron pin on the North side of Hagood Road; thence along Hagood Road S. 87-12 W., 100 feet to the beginning corner.
