Annie Lucile Sawyer, her heirs and assigns, forever:

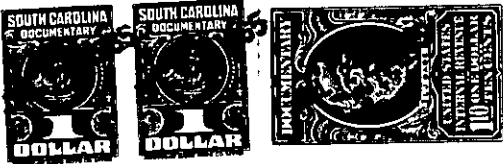

BEGINNING at an iron pin on N.
