to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said AGNEW ROAD-BAPTIST CHURCH, Its Successors and Assigns:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 18 of a subdivision known as Woodbriar, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book EE at Page 6, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of Woodbriar Court at the joint front corner of Lots 18 and 19 and running thence S 76-37 E 191.4 feet to a point at the joint rear corner of Lots 18 and 19; thence N 22-17 E 35 feet to a point at the rear corner of Lot 18; thence N 52-15 W 235.5 feet to a point on the Eastern side of Woodbriar Court at the front corner of Lot 18; thence with the Eastern side of Woodbriar Court S 22-10 W 36.7 feet to a point; thence continuing with the Eastern side of Woodbriar Court S 00-25 E 98.3 feet to the point of beginning.
