unto William K. Cole and Martha P. Cole, their heirs and assigns forever:

All those pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, on the eastern side of Rose Garden Street and being known and designated as Lots Nos. 42, 43, 44, 45 and 46, Block D, of Buena Vista, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "W", at Page 11 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Rose Garden Street at the joint front corner of Lots Nos. 41 and 42 and running thence along the joint line of said lots N. 80-17 E. 150 feet to an iron pin; thence S. 9-43 E. 175 feet to an iron pin; thence along the joint line of Lots Nos. 46 and 47 S. 80-17 W. 150 feet to an iron pin; thence along the eastern side of Rose Garden Street N. 9-43 W. 175 feet to the point of beginning.
