KNOW ALL MEN BY THESE PRESENTS, that I, D. U. Mauldin, of Greenville County,

in consideration of Fourteen Thousand, Seven Hundred and No/100-----(\$ 14,700.00)--- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Parnell Q. DuBois and Blanch A. DuBois, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 102, Pine Forest, as shown on a plat prepared by Dalton & Neves dated August, 1959, recorded in the R. M. C. Office for Greenville County in Plat Book QQ at pages 106 and 107 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Mapleton Drive at the joint front corner of Lots Nos. 102 and 103 and running thence with the line of Lot No. 103, N. 26-30 W. 138 feet to an iron pin at the joint rear corner of Lots Nos. 55, 56, 102 and 103; thence with the rear line of Lot No. 56, S. 63-30 W. 100 feet to an iron pin at the joint rear corner of Lots Nos. 56, 57, 101 and 102; thence with the line of Lot No. 101, S. 26-30 E. 138 feet to an iron pin on the Northern side of Mapleton Drive; thence with the Northern side of Mapleton Drive, N. 63-30 E. 100 feet to the point of beginning; being the same conveyed to the grantor by Wooten Corporation of Wilmington by deed dated November 17, 1964, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 763 , at Page 426 .
