whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and
release unto **WILMER R. VOLLNOGLE AND MARJORIE C. VOLLNOGLE**:

All that piece, parcel or lot of land situate, lying and being on the Western
side of Welcome View Drive near the City of Greenville, County of Greenville,
State of South Carolina, being known and designated as Lot No. 2 as shown on a
plat prepared by Dalton & Neves, Engineers, dated January, 1965, entitled
"Property of Dempsey Construction Co., Inc.", recorded in the R.M.C. Office for
Greenville County, South Carolina, in Plat Book III at page 127, and having
according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Welcome View Drive at the joint
front corner of Lots Nos. 1 and 2, and running thence with the line of Lot No. 1
S. 59-0 W. 160 feet to an iron pin in the line of Lot No. 4; thence with the
line of Lot No. 4 S. 31-0 E. 100 feet to an iron pin at the joint rear corner
