BEGINNING at an iron pin on the western side of Charing Cross Road, joint front corner of Lots Nos. 43 and 44, and running thence along the western side of Charing Cross Road, N. 7-04 E. 62 feet to an iron pin; thence continuing along the western side of Charing Cross Road, N. 12-25 E. 62.8 feet to an iron pin at the joint front corner of Lots Nos. 44 and 45; thence along the joint line of said lots, N. 76-35 W. 130 feet to an iron pin; thence S. 8-10 W. 140.3 feet to an iron pin at the rear corner of Lot No. 43; thence along the line of that lot, S. 83-45 E. 126 feet to the beginning corner.
