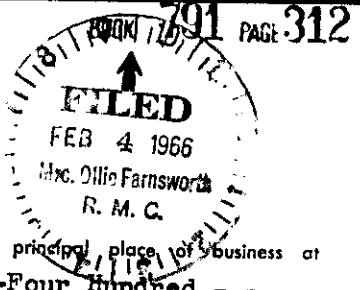
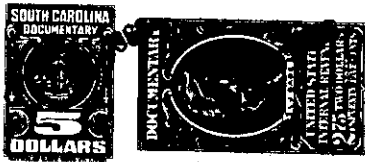

KNOW ALL MEN BY THESE PRESENTS, that **Real Estate Fund**

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto **Blake P. Garrett and David H. Garrett their Heirs and Assigns forever:**

All those two pieces, parcels or lots of land lying, being and situate in the County and State aforesaid, Fairview Township and in the Town of Fountain Inn, in the subdivision known as Inn Village, known and designated on a plat of the same prepared by W. N. Willis, Engineer, February 25, 1960, as Lots Nos. 23 & 26, said Plat of record in the R. M. C. Office for Greenville County, S. C., in Plat Book RR, Page 61, and having according to said Plat the following courses and distances, to-wit:

Lot No. 23- Beginning at an iron pin in the Western edge of Inn Circle Street, joint corner with Lot No. 24, and running thence with the Western edge of said Street S. 37-00 E. 100 feet to an iron pin; thence S. 53-00 W. 186.7 feet to an iron pin; thence N. 37-00 W. 100 feet to an iron pin, back joint corner with Lot No. 24; thence with the joint line of said Lot No. 24 N. 53 E. 186.7 feet to an iron pin, the point of beginning, and bounded by Lot No. 24, Inn Circle Street and others.

Lot No. 26 - Beginning at an iron pin in the Eastern edge of Inn Circle Street, joint corner with Lot No. 44; thence with the back joint line of said Lot 44 N. 53-00 E 100 feet to an iron pin, joint corner with Lots Nos. 44, 43 and 27; thence with the joint line of said Lot No. 27, S. 37-00 E. 150 feet to an iron pin in the Northern edge of Inn Circle Street, joint corner Lot No. 27; thence with the Northern edge of said Street S. 53-00 W. 80 feet to an iron pin; thence with curvature of said street to an iron pin in the Eastern edge of said Street; thence with the Eastern edge of said Street N. 37-00 W. 130 feet to an iron pin, the point of beginning, and bounded by Lots Nos. 44, 43, 27 and Inn Circle Street.

This conveyance is made subject to the covenants, restrictions and limitations as set forth in a deed which is of record in Deed Book 659, Page 225 in said R. M. C. Office for Greenville County, S. C.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs or successors and assigns, forever. And, the grantor does hereby bind itself and its successors to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
