ALL that piece, parcel or lot of land with improvements thereon situate, lying and being in the County of Greenville, State of South Carolina, on the Eastern side of the Greenville to Sandy Flat Road in O'Neal Township, near Jackson Grove Methodist Church, being part of Tract No. 1 on plat of Charles Gilsreath Estate made by H. S. Brockman, September 5, 1934 and having, according to said plat, the following metes and bounds:
