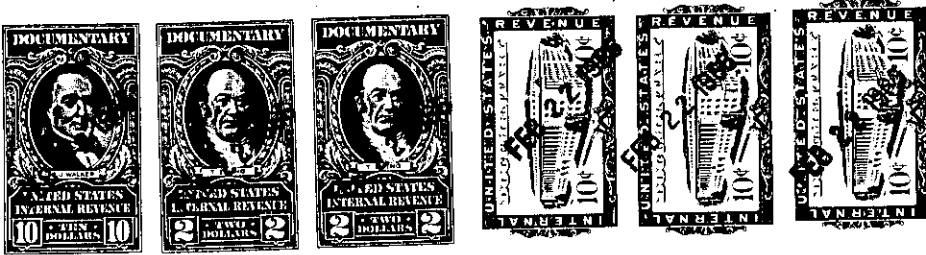
KNOW ALL MEN BY THESE PRESENTS, that David R. Jones
