KNOW ALL MEN BY THESE PRESENTS, that ROY E. HIGH

in consideration of Four Thousand One Hundred Eighty-Two and 94/100----- Dollars,
and assumption of mortgage described below
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto ROBERT J. WILLIAMS and PATRICIA S. WILLIAMS, Their Heirs and Assigns:

ALL that piece, parcel or lot of land, with the buildings and improvements thereon,
situate, lying and being near the City of Greenville, County of Greenville, State of
South Carolina, being known and designated as Lot 30 on plat of property of E. P.
Kerns, which plat is recorded in the RMC Office for Greenville County, South Caro-
lina, in Plat Book W at page 17, and having, according to said plat, the following
metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of McArthur Street (also known as
Antioch Street) at the joint front corner of Lots 29 and 30; and running thence with
the line of Lot 29, N. 86-52 W. 172.4 feet to an iron pin; thence with the rear line
of Lot 21, S. 19-39 W. 50 feet to an iron pin at the joint rear corners of Lots Nos.
30 and 31; thence with the line of Lot No. 31, S. 36-15 E. 188.6 feet to an iron pin
on the West side of McArthur Street (Antioch Street); thence with the Western side
of said street, N. 0-50 E. 50 feet to the point of beginning.

As a part of the consideration hereof, the Grantees agree to assume and pay, accord-
ing to its terms, that certain note and mortgage given to Carolina Federal Savings
and Loan Association on which there is a balance due of \$3,592.06; said mortgage
