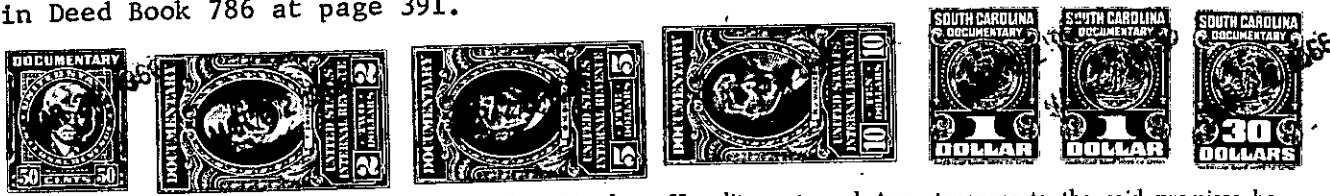

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto **J.W. ALLISON AND VIRGINIA LEE ALLISON:**

All that piece, parcel or lot of land situate, lying and being on the Southwestern side of Delray Circle near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 3 as shown on a plat entitled "Final Plat, Section Two, Farmington Acres", prepared by Carolina Engineering & Surveying Co., dated September 24, 1964, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at page 27, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Delray Circle at the joint front corner of Lots Nos. 2 and 3, and running thence with the line of Lot No. 2 S. 48-43 W. 150.0 feet to an iron pin; thence N. 41-17 W. 100 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence with the line of Lot No. 4 N. 48-43 E. 150.0 feet to an iron pin on the Southwestern side of Delray Circle; thence with the Southwestern side of Delray Circle S. 41-17 E. 100 feet to the point of beginning.
