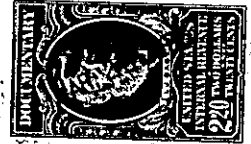

KNOW ALL MEN BY THESE PRESENTS, that Greenville Land Co., Inc.

A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Three Thousand, Seven Hundred Fifty and No/100-----(\$ 3,750.00)----- Dollars,

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Henry C. Harding Builders, Inc.; its successors and assigns forever:

All those pieces, parcels or lots of land, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lots 1, 3 and 17 of a subdivision known as Edgeworth as shown on a plat thereof prepared by Piedmont Engineers and Architects, dated October 15, 1965 and recorded in the R. M. C. Office for Greenville County in Plat Book LLL at Page 113 and having, according to said plat, the following metes and bounds, to-wit:

LOT 1: BEGINNING at an iron pin on the northern side of Buxton Court, joint front corner of Lots 1 and 2 and running thence with the joint line of said lots, N. 1-58 E. 175.45 feet to an iron pin; thence S. 87-43 E. 80.85 feet to an iron pin on the western side of Old Dunham Bridge Road; thence with said road, S. 15-20 E. 153.1 feet to an iron pin; thence continuing with said road, S. 5-12 E. 3.8 feet to an iron pin; thence continuing with said road as it intersects with Buxton Court, following the curvature thereof, the chord of which is S. 43-19 W. 33.1 feet to an iron pin on the northern side of Buxton Court; thence with said Court, N. 88-02 W. 130 feet to the beginning corner.

LOT 3: BEGINNING at an iron pin on the northern side of Buxton Court, joint front corner of Lots 2 and 3 and running thence with the joint line of said lots, N. 1-58 E. 176 feet to an iron pin; thence N. 87-43 W. 95 feet to an iron pin at the corner of Lot 4; thence with the line of Lot 4, S. 1-58 W. 176.5 feet to an iron pin on the northern side of Buxton Court; thence with said Court, S. 88-02 E. 95 feet to the beginning corner.

LOT 17: BEGINNING at an iron pin on the southern side of Buxton Court, joint front corner of Lots 16 and 17 and running thence with the joint line of said lots, S. 1-58 W. 175.5 feet to an iron pin; thence S. 88-02 E. 131.95 feet to an iron pin on the western side of Old Dunham Bridge Road; thence with said road, N. 5-12 W. 151.85 feet to an iron pin; thence continuing with said road as it intersects with Buxton Court, following the curvature thereof, the chord of which is N. 46-37 W. 37.5 feet to an iron pin on the southern side of Buxton Court; thence with Buxton Court, N. 88-02 W. 110 feet to the beginning corner.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.
