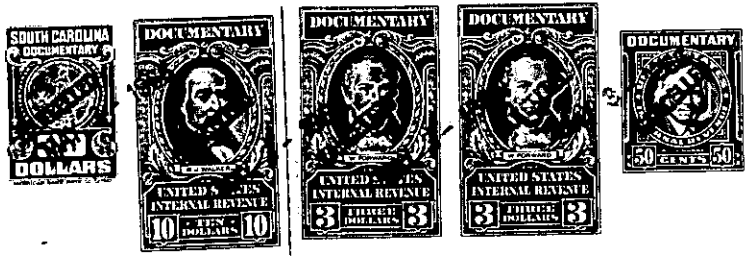
R. H. POPE and MARY G. POPE. their heirs and assigns forever,
