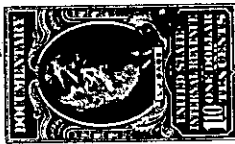

BEGINNING at a point on the southern side of Pendleton Street, joint front corner of property of the grantor and property now or formerly belonging to Mrs. E. J. Clifton and running thence along the southern side of Pendleton Street, S. 65-18 E. 60.46 feet to a point; thence running S. 20-43 W. 9.2 feet to an iron pin; thence running N. 65-0 W. 60.9 feet along the right of way line of the new highway to an iron pin; thence running N. 22-42 E. 7.8 feet to the point of beginning. Said area comprises 515 square feet. This being a portion of the property acquired by the grantor by deed dated September 7, 1937, recorded in the RMC Office for Greenville County in Deed Book 200 at page 145.
