CONSENT TO RIGHT OF WAY

WHEREAS, Fred R. Stapleton and Betty A. Stapleton of Greenville County, South Carolina, by right of way deed dated January 12, 1966 did grant and convey unto the Berea Public Service District Commission a right of way for the purpose of constructing, installing and maintaining a sewer pipe line across property of the said Fred R.
