the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto P. Salem Eassy, Jr. and Gail B. Eassy, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 177 on Potomac Avenue in Pleasant Valley on a plat made by Dalton & Neves, Engineers, in April, 1946 and revised in November, 1948, which is recorded in Plat Book P at page 92 in the R. M. C. Office for Greenville County, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Potomac Avenue, joint front corner of Lots Nos. 177 and 178, said pin being 345 feet in an easterly direction from the intersection of Potomac Avenue and Panama Avenue and running thence along the common line of said lots N. 0-08 W. 160 feet to an iron pin; thence across the rear line of Lot No. 177 N. 89-52 E. 60 feet to an iron pin; thence with the common line of Lots Nos. 176 and 177 S. 0-08 E. 160 feet to an iron pin on the northern side of Potomac Avenue; thence along said Avenue S. 89-52 W. 60 feet to an iron pin, the point of beginning.
