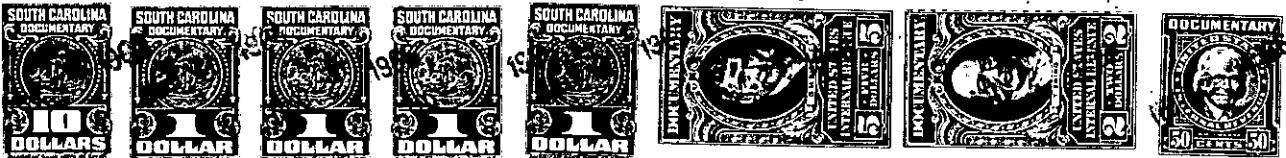
ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Four (4) of Section Two (2) of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated August 30, 1965, and recorded in the R. M. C. Office for Greenville County in plat Book "JJJ" at page 71 and having, according to said plat the following metes and bounds:

BEGINNING at an iron pin on the North side of East Seven Oaks Drive at the joint front corners of Lots 5 and 4 and running along said lot lines N 35-11 E 251 feet to an iron pin at the joint rear corners of Lots 5 and 4; thence turning and running along the rear lot line of Lots 4 S 79-48 E 69 feet to an iron pin at the joint rear corners of Lots 3 and 4; thence turning and running along the joint lot lines of Lots 3 and 4 S 10-40 E 242.5 feet to an iron pin on the North side of Chapman Road; thence turning and running along Chapman Road S 71-10 W 65 feet to an iron pin; thence continuing along Chapman Road S 68-35 W 56.4 feet to an iron pin on Chapman Road; thence around the curve of Chapman Road and East Seven Oaks Drive N 81-55 W 39.4 feet to an iron pin on the North side of East Seven Oaks Drive; thence continuing along East Seven Oaks Drive N 48-18 W 89.7 feet to an iron pin; thence continuing along East Seven Oaks Drive N 54-49 W 35 feet to the point of beginning.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the R. M. C. Office for Greenville County in Vol. 784 at page 329.
