Frank Woodrow Loftis Jr., his heirs and assigns forever:

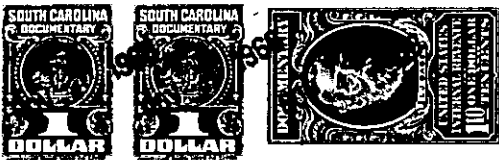

C. in Plat Book M, at page 33 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Cammer Avenue at the joint corner of Lots 41 and 42; thence with the southeasterly side of Cammer Avenue N 42-10 E 90 Feet to an iron pin in the center of the front line of Lot No. 43; thence on a new line through lot No. 43 S 47-50 E 165 feet to an iron pin in the center of the rear lot line of Lots 43 and 50; thence with the rear line of Lots 50 and 51 S 42-10 W 90 Feet to an iron pin at the joint rear corner of Lots 41, 42, 51 and 52; thence with the line of Lot# 41 N 47-50 W 165 feet to the point of beginning.
