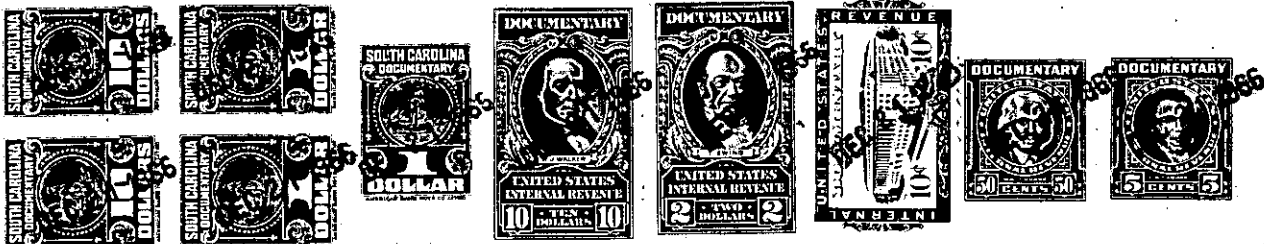
KNOW ALL MEN BY THESE PRESENTS, that C. C. Davis -----
