bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

James V. Patterson, his heirs and assigns:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, lying on the northern side of Fleetwood Drive, near the City of Greenville, being known as Lot 30 on a plat of Magnolia Acres recorded in Plat Book GG, Page 133, and being more particularly shown on a plat of the property of Kenneth Harrison McClain prepared by R. B. Bruce dated May 28, 1959, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the northern side of Fleetwood Drive, front corner of Lot 29 which pin is 346 feet northeast of the intersection of said drive with Cool Brook Drive and running thence with the line of Lot 29 N. 25-49 W. 175 feet to an iron pin; thence N. 64-11 E. 85 feet to an iron pin at rear corner of Lot 31; thence with the line of said lot S. 25-49 E. 175 feet to an iron pin on the northern side of Fleetwood Drive; thence with the northern side of said drive S. 64-11 W. 85 feet to the beginning corner.

This conveyance is made subject to easements, rights-of-way and restrictions of record including restrictions recorded in Deed Book 543, page 41.

As part of the consideration herein the grantee assumes and agrees to pay that certain mortgage given by the grantor herein to Sumner G. Whittier as Administrator of Veterans' affairs dated August 1, 1959, and recorded in the R.M.C. Office for Greenville County on August 1, 1959, in Mortgage Book 798 at page 221 upon which the present unpaid balance is \$10,994.25.
