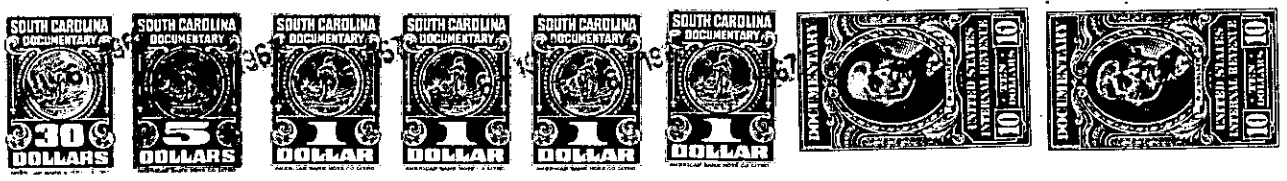
KNOW ALL MEN BY THESE PRESENTS, that We, Floyd B. Stewart and Jane A. Stewart

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ROBERT F. CAMBY and VERA B. CAMBY, their heirs and assigns forever;

ALL THAT CERTAIN piece, parcel or tract of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, lying on the northern side of Pelham Road and consisting of approximately 2.40 acres as shown on plat of Property of Floyd B. Stewart recorded in the RMC Office for Greenville County in Plat Book NNN , and Page 44 , and having, according to said plat, the following metes and bounds, to-wit:

Hudson and grantees approximately 6 feet to a point; thence along the branch which is the property line and the traverse of, which is N. 8-31 W. 54.9 feet, N. 34-10 W. 258 feet, to a point; thence N. 85-36 E. 20 feet to an iron pin; thence N. 85-36 E. 465 feet to an iron pin on the Western side of a county road; thence along the county road S. 5-38 E. 218.5 feet to the point of beginning.
