in consideration of the sum of Sixteen Hundred and No/100 (\$1600.00)-----DOLLARS, and assumption of the mortgage referred to below, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Furman O. Burgess, his Heirs and Assigns, forever:

ALL that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 60 on plat of the Revision of the Extension of Shamrock Acres, recorded in the RMC Office for Greenville County in Plat Book RR, Page 133, and having, according to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin on the northwesterly side of Kingswood Drive at the joint front corner of Lots 59 & 60 and running thence with the common line of said Lots, N 54-45 W, 146.5 feet to an iron pin; thence S 37-20 W, 116.3 feet to an iron pin on the northeasterly side of County Cork Drive; thence with said Drive, S 53-0 E, 127.7 feet to an iron pin; thence around a curve at the intersection of County Cork Drive and Kingswood Drive (the chord of which is N 82-0 E) 28.3 feet to an iron pin on the northwesterly side of Kingswood Drive; thence with said Drive, N 37-0 E, 100 feet to the point of beginning.

THE grantee assumes and agrees to pay that mortgage given by Stanley J. Harris to Carolina Federal Savings and Loan Association of Greenville in the original amount of \$9,600.00 on which there remains unpaid a principal balance of \$8,950.22, which mortgage is of record in the RMC Office for Greenville County in Mortgage Book 957, Page 46..
