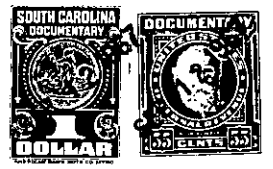

KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore,

in consideration of - - Three Hundred Eighty-five and No/100 (\$385.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Ernest R. Bolton and Annie Mae Bolton, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 50 of a subdivision known as Monticello Estates, as shown by a Plat thereof, by Woodward Engineering Co., dated March 1956, and recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 169, and having according to said Plat the following description, to-wit:

BEGINNING on South Monticello Road at an iron pin at joint front corners of lots 49 and 50 and running thence 80 feet with the line of said Road to an iron pin at joint front corners of lots 50 and 51; running thence 180 feet with the side line of lot 51 to an iron pin at joint rear corners of lots 50 and 51 and Watts property; running thence 80 feet with the line of Watts property to an iron pin at joint rear corners of lots 49 and 50; running thence 180 feet with the side line of lot 49 to the iron pin at joint front corners of lots 49 and 50 on South Monticello Road, the point of beginning.

NO residence to cost less than \$5,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 40 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay taxes for 1967.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
