KNOW ALL MEN BY THESE PRESENTS, That we, William F. Robertson of 410 Byrd Boulevard, Greenville, South Carolina, our true and lawful Attorney in Fact, for us, and in our name and stead to perform the following acts and deeds:

To receive for us and in our stead all money or notes and mortgages that may be given for the said real estate, and to execute and deliver to such purchaser or purchasers all receipts, satisfactions or cancellations for the completion of the transaction herein contemplated.

To retain for us and in our stead Attorneys and Real Estate Agents for the purpose of expediting the powers herein granted concerning the aforesaid premises.
