KNOW ALL MEN BY THESE PRESENTS, that we, Daniel W. Wilson and Lena V. Wilson,

in consideration of One (\$ 1.00) Dollar and correction of deed Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. H. Mauldin, his heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 3 of Brookwood Forest, Section Two (Part One) as shown on plat thereof prepared by Madison H. Woodward, Engineer, June 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book WW, at Page 522, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Charing Cross Road, joint corner Lots Nos. 2 and 3, and running thence along the northern side of Charing Cross Road, S. 59-15 E. 15 feet to an iron pin; thence continuing along the northern side of Charing Cross Road, S. 54-01 E. 34 feet to an iron pin; thence continuing along the northern side of Charing Cross Road, S. 56-11 E. 51 feet to an iron pin at the corner of Lot No. 4; thence along the line of that lot, N. 1-29 E. 165 feet to an iron pin; thence N. 86-31 W. 95 feet to an iron pin at the rear corner of Lot No. 2; thence along the line of that lot, S. 2-29 W. 140 feet to the beginning corner; being the same conveyed to us by Mauldin Construction Co. by deed dated March 12, 1965, and recorded in the R. M. C. Office for Greenville County in Deed Vol. , at Page .

The courses and distances on the above mentioned plat are incorrect and a new survey of Section Two (Part One) Brookwood Forest was made by Webb Surveying and Mapping Co. by plat dated September 8, 1967 and recorded in the R. M. C. Office for Greenville County in Plat Book RRR at Page 141. All owners in said subdivision are reconveying their property according to the first mentioned plat to J. H. Mauldin and the said J. H. Mauldin will reconvey the property according to the latter mentioned plat. The grantors herein do hereby waive any violations of side line setback requirements created by the protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 785 at Page 323.
