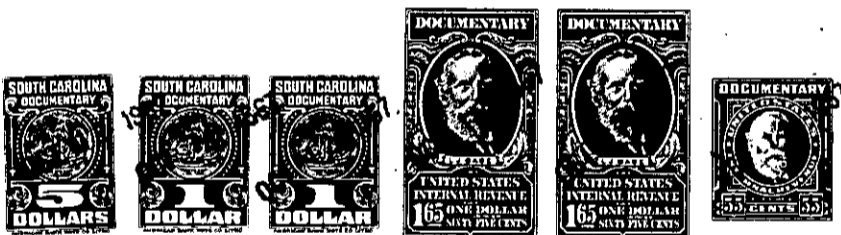
JAMES T. VITTEGLEO AND LENA O VITTEGLEO, THEIR HEIRS AND ASSIGNS:
