A. M. Bridges, his heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot # 17 of a subdivision known as "Addition to Sheffield Forest", as shown on a plat prepared by Piedmont Engineers & Architects, dated May 4, 1965, and recorded in the R. M. C. Office for Greenville County in Plat Book III, at Page 122, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Confederate Avenue, joint front corner of Lots 16 and 17, and running thence with the joint line of said lots, S. 79-31 E. 140 feet to an iron pin; thence S. 10-29 W. 217.8 feet to an iron pin; thence N. 78-46 W. 15 feet to an iron pin, joint rear corner of Lots 17 and 18; thence with the joint line of said lots, N. 32-11 W. 240.9 feet to an iron pin on the southeastern side of Confederate Avenue; thence with Confederate Avenue, following the curvature thereof, the chord of which is N. 53-51 E. 55.7 feet to the beginning corner;

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises .

As a part of the consideration for this conveyance, the grantee expressly assumes and agrees to pay the balance due on that certain note and mortgage, in the original sum of \$17,000.00 executed by the grantor to First Federal Savings and Loan Association of Greenville and recorded in the R. M. C. Office for Greenville County in Mortgage Book 1063 at Page 86, the balance due thereon being the sum of \$17,000.00 as of this date.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
