in consideration of the sum of One and No/100 (\$1.00)-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said BETTY P. PRICE, Her Heirs and Assigns, Forever:

ALL my interest in the following described property, all that piece, parcel or lot of land lying and being in Greenville County, State of South Carolina having the following description:

BEGINNING on a stake in the road on the outside line, the Clelia A. Poole corner, and running with said road N 32-00 W 409 feet to a stake in the road; thence S 68-30 W crossing the branch and the Gap Creek Road 1050 feet to the outside line at the top of the mountain; thence with the outside line S 47-00 E 850 feet to a stake; thence N 22-30 E 528 feet to a stake on the south side of old Gap Creek Road; thence N 68-30 E 390 feet to a stake in the road, the beginning corner. Containing 11.25 acres more or less.

The above described land is better shown by a blue print made by W. P. Morrow, Land Surveyor, and is known as lot no. 1 of the subdivision of the estate of W. W. Poole.

W. W. Poole died intestate on October 18, 1950 owning the above property at the time of his death, and more fully shown by reference to Apt. 276, File 33, Probate Court for Greenville County. Mary Guest, a daughter of the said W. W. Poole and the wife of the grantor herein, subsequently died intestate and leaving as her sole heirs at law the grantor, J. B. Guest, her husband, and an only child, James R. Guest. The purpose of this deed is to convey to the grantee any and all interest which the grantor acquired as a heir of Mary Guest, deceased.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
