in consideration of the sum of Six Thousand Nine Hundred Fifty and No/100 (\$6,950.00)-----DOLLARS,

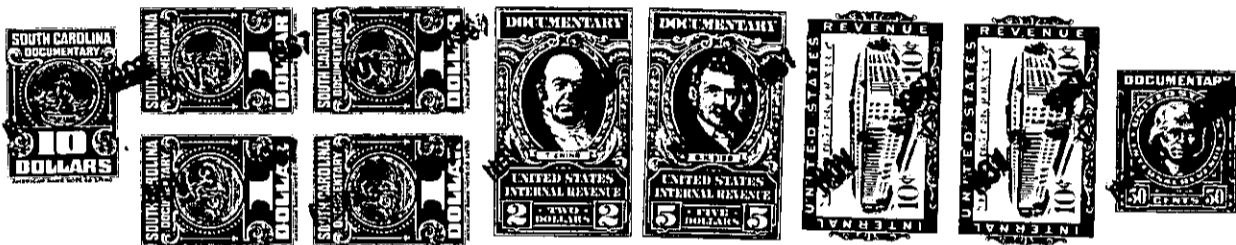
