

BEGINNING at an iron pin on the southeastern side of Dunlap Drive, joint front corner of Lots 8 and 9 and running thence along the joint line of said lots, S. 66-25 E. 131.9 feet to an iron pin; thence S. 23-35 W. 70 feet to an iron pin at the joint rear corner of Lots 9 and 10; thence along the joint line of said lots, N. 66-25 W. 130 feet to an iron pin on the southeastern side of Dunlap Drive; thence along the southeastern side of Dunlap Drive, N. 23-35 E. 50 feet to an iron pin; thence continuing along the southeastern side of Dunlap Drive, N. 18-14 E. 20 feet to the beginning corner.
