C. according to a plat made October 22, 1962 by R. K. Campbell, Engineer and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "YY" Page 93 and being more particularly described as follows:

BEGINNING at an iron pin on the South Side of Timrod Way, joint front corner of Lots 32 and 33 and running along Timrod Way N. 33-55 E. 160 feet to an iron pin, joint front corner of Lots 31 and 32; thence along the line of Lot 31 S. 56-05 E. 185 feet to an iron pin, joint rear corner of Lots 31 and 32; thence S. 33-55 W. 160 feet to an iron pin, joint rear corner of Lots 32 and 33; thence along the line of Lot 33 N. 56-05 W. 185 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 723, Page 105; and also a building set back line no less than fifty(50) feet from the street.
