unto

Bobby J. Hill, his heirs and assigns forever:

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina situate, lying and being on the northwestern side of Mayflower Street and being known and designated as Lots Nos. 6, 7, 8 and 9, Block B of Buena Vista Subdivision, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "W", at Pages 11 and 29 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Mayflower Street, joint front corner of Lots Nos. 9 and 10 and running thence with the common line of said lots N. 47-08 W. 150 feet to an iron pin; thence with the rear line of Lots 6 - 9 N. 42-52 E. 140 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6 and running thence with the common line of said lots S. 47-08 E. 150 feet to an iron pin on the northwestern side of Mayflower Street; thence with Mayflower Street S. 42-52 W. 140 feet to an iron pin, the point of beginning.
