in consideration of One Hundred Thirty-Eight and 75/100 (\$138.75)-----Dollars,

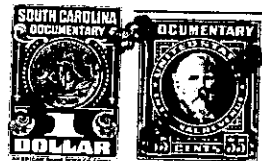
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina near the City of Greenville and being known as a portion of the Property of Maude L. Dawson and also being shown as Addition to the Phillips Property according to a more recent survey by Webb Surveying and Mapping Company made in October of 1966 and being recorded in the R. M. C. Office for Greenville County in Plat Book _____ at Page _____ and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin, common rear corner of Lots Nos. 3 and 4 according to said plat, common corner of property of the grantees and Birdie Marie Phillips and running thence N. 41-00 W. 25 feet to an iron pin; thence N. 43-45 E. 194.1 feet to an iron pin; thence S. 43-00 E. 25 feet to an iron pin; thence with the rear line of the grantees property S. 43-45 W. 195 feet to an iron pin, the point of beginning, said strip containing .111 acres.
