KNOW ALL MEN BY THESE PRESENTS, that We, John C. Cothran and Ellis L. Darby, Jr.

in consideration of Ten Thousand and No/100 (\$10,000.00) and assumption of mortgage set forth below, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Glen R. Miller and Helen F. Miller, their heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northwesterly side of Providence Square, near the City of Greenville, S. C., being known and designated as Lot No. 6, Section Two, Pelham Estates, as recorded in the RMC Office for Greenville County, S. C. in Plat Book PPP, at page 119 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Providence Square, said pin being the joint front corner of Lots 6 and 7 and running thence with the common line of said Lots N 71-47 W 199.4 feet to an iron pin, joint rear corner of Lots 6 and 7; thence S 18-07 W 150 feet to an iron pin, joint rear corner of Lots 6 and 5; thence with the common line of said Lots S 71-48 E 199.2 feet to an iron pin on the northwesterly side of Providence Square; thence with the northwesterly side of Providence Square N 18-12 E 150 feet to an iron pin, the point of beginning.

This conveyance is subject to all restrictions, setback line, roadways, easements and rights-of-way, if any, affecting the above described property, including restrictions recorded in Deed Book 827, page 215, and 20 foot utility easement across the rear of said lot as shown on the recorded plat.

As a part of the consideration herein the grantees do hereby assume and agree to pay the balance due of \$28,000.00, on that certain mortgage given by the grantors herein to Fidelity Federal Savings and Loan Association, in the face amount of \$28,000.00, dated September 18, 1967, and recorded in the RMC Office in Mortgage Book 1069, page 395.
