the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Joseph D. Boyter, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 30, Section I of a subdivision known as Richmond Hills as shown on plat thereof prepared by Carolina Engineering & Surveying Co., April 20, 1965 and recorded in the R. M. C. Office for Greenville County in Plat Book JJJ at Page 81 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Lynchburg Drive at the joint front corner of Lots 30 and 31 and running thence with the joint line of said lots, N. 60-45 W. 150 feet to an iron pin in the line of Lot 32; thence with the line of Lot 32 and continuing with the line of Lot 33, S. 29-15 W. 100 feet to an iron pin, joint rear corner of Lots 29 and 30; thence with the joint line of said lots, S. 60-45 E. 150 feet to an iron pin on the northwestern side of Lynchburg Drive; thence with Lynchburg Drive, N. 29-15 E. 100 feet to the beginning corner; being the same conveyed to me by Williams Land Company, Inc. by deed dated November 28, 1967 and recorded in the R. M. C. Office for Greenville County.
