Norma M. Finlay, her heirs or assigns, forever:

ALL that certain piece, parcel or lot of land situate in Austin Township, Greenville County, State of South Carolina, in the Town of Simpsonville, S. G., and being Lot No. 77 in a Subdivision of lands known as FOREST PARK as shown by plat thereof prepared by C. O. Riddle, Surveyor, dated October, 1952, and recorded in the RMC Office for Greenville County in Plat Book BB, Pages 70 and 71, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Forest Park Drive and running thence N. 13-23 W. 111.4 feet to an iron pin on the southern bank of a branch; thence running along the same course, 17.9 feet to the center of said branch; thence running along said branch as the line by a traverse line, N. 89-46 W. 137.2 feet to a point in the center of branch; thence S. 3-46 E. 144 feet to an iron pin on the north side of Forest Park Drive at the joint front corner of Lots Nos. 77 and 78; thence running along the right-of-way of Forest Park Drive, N. 86-14 E. 70 feet to an iron pin; thence continuing along the right-of-way of Forest Park Drive, N. 80-32 E. 52 feet to the beginning corner, which is the joint front corner of Lots Nos. 76 and 77.

Being the same property conveyed the grantor herein by deed recorded in deed Volume 587 at Page 353 in the RMC Office for Greenville County.

This conveyance is made subject to any restrictive covenants, building set-back lines, rights-of-way and easements which may affect the above described property.
