to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto

BYRDIE K. SMITH, her heirs and assigns forever:

ALL that certain piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina on the southwestern side of Laurel Street, being a portion of Lot No. 2 as shown on a Plat of property of G. Dewey Oxner, recorded in the Greenville County R. M. C. Office in Plat Book GG, at Page 42 and, having according to a more recent Plat entitled "Survey for Byrdie K. Smith" by Piedmont Engineers and Architects dated August 23, 1968, the following metes and bounds, to-wit:

BEGINNING at a point on the southwestern side of Laurel Street at the joint front corner of Lots 2 and 3, said point being located a distance of 640 feet, more or less, from the right of way of U. S. Highway No. 25 and running thence along the joint line of lots 2 and 3, S. 33-54 W. 100 feet to a point; thence N. 55-54 W. 50 feet to a point in the line of Lot No. 1; thence with the joint line of Lots 1 and 2, N. 33-54 E. 100 feet to a point on the southwestern side of Laurel Street; thence with Laurel Street S. 55-54 E. 50 feet to the point of beginning, being a portion of the property conveyed to the Grantor herein by deed of Hazel Price Callahan dated August 1, 1947 and recorded in Deed Book 316, at Page 204.
