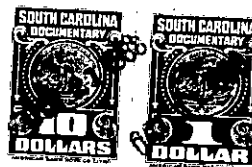
KNOW ALL MEN BY THESE PRESENTS, that DILLARD JACK HICE AND SYBIL H. HICE

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto WILLIAM B. HARDIN, JR., his heirs and assigns forever:

ALL of that lot of land in the County of Greenville, State of South Carolina, in the Village of S. Slater & Sons, Inc., at Slater, S.C., known as Lot 34, Block C on plat of J.E. Serrine & Co., Engineers, dated July 10, 1940, recorded in the R. M.C. Office for Greenville County in Plat Book K at pages 63, 64 & 65 and having, according to said plat, the following metes and bounds, to-wit:
