Field, Giant Tiger, Grant's Store, Grant Department Stores, Mason's, Maxam's, Miracle Mart, Shopper's City, Shopper's Fair, Shopper's World Stores, and Spartan Discount Department Store, or any store of similar operation, whether operated as a so-called "closed door" store or otherwise.

(3) This land is being acquired by the purchaser herein as a site for the office of the Greenville County Chapter American National Red Cross. No building or other construction shall be placed or located on the premises above described for a period of twenty (20) years from the date of this deed until the exterior construction and location of such building has been approved by Hughes Real Estate Company and Cedar Lane Gardens, Inc.

(4) The purchaser shall maintain no exterior facilities for the disposition of trash, waste or garbage unless same shall be properly screened so as to create no objectionable sights or odors. (The waste disposal arrangement now in use at the Volkswagen distributor on adjacent property is an example of an approved and proper exterior waste disposition arrangement.)

(5) The purchaser shall carry on no offensive or noxious activity upon the premises and shall do nothing which shall constitute a nuisance thereon.

This property is conveyed subject to usual easements, restrictions and rights of way of record.
