the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto W. M. Rose, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 13 of a subdivision known as Green Pastures as shown on plat thereof prepared by Carolina Engineering & Surveying Co., March 20, 1965 and recorded in the R. M. C. Office for Greenville County in Plat Book III, at Page 133, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Stacey Drive, joint front corner of Lots Nos. 13 and 14, and running thence along the eastern side of Stacey Drive, S. 27-32 E. 75.0 feet to an iron pin; thence following the curvature of a bend in Stacey Drive, the chord being S. 69-12 E. 37.3 feet, to an iron pin on the northern side of Stacey Drive; thence along the northern side of Stacey Drive, N. 69-07 E. 183.0 feet to a point in a branch, the joint corner of Lots Nos. 12 and 13; thence up the meanders of said branch, a traverse line being N. 35-29 W. 104.7 feet, to a point in said branch, the joint rear corner of Lots Nos. 13 and 14; thence along the joint line of said lots, S. 69-07 W. 201.0 feet to the beginning corner.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat (s), or on the premises.
