to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

ODELL PUTMAN, HIS HEIRS AND ASSIGNS, FOREVER:

All that certain piece, parcel, or lot of land in the County of Greenville, State of South Carolina, being the southeasterly portion of Lot No. 24, of Clairemont Ridge, plat of which is recorded in the RMC Office for Greenville County, S. C., in Plat Book "H", at Page 182, and having the following metes and bounds, to wit:

BEGINNING at a point on the northeasterly side of Piney Mountain Road, joint corner of Lots Nos. 24 and 25, and running thence along easterly side of Piney Mountain Road N. 36-30 W. 88.88 feet to an iron pin in the front line of Lot No. 24; thence through Lot No. 24 N. 46-35 E. 368.8 feet to an iron pin in the rear line of said lot; thence along the rear line of said lot S. 45-30 E. 88.38 feet to the joint rear corner of Lots Nos. 24 and 25; thence with said lots S. 46-35 W. 382.3 feet to the point of BEGINNING.

ALSO: The adjoining northwesterly portion of Lot No. 25, as shown on the above mentioned plat, having the following metes and bounds, to wit:

BEGINNING at a stake on the northeasterly side of Piney Mountain Road, at corner of Lot No. 24, and running thence with line of said lot N. 46-35 E. 382.3 feet to a stake; thence S. 45-30 E. 36 feet to a point; thence on a line through Lot No. 25 S. 51-32 W. 387 feet to a point on Piney Mountain Road; thence with the northeasterly side of said Road N. 36-30 W. 1 foot to the point of BEGINNING.
