ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in Paris Township, being known and designated as Lot No. 143 Bellwood Road, as shown on a Plat of Section 2, Bellwood Estates, dated 1955 by Woodward Engineering Co., recorded in the R.M.C. Office for Greenville County in Plat Book GG, at Page 50, and having, according to said plat, the following description, to-wit:
