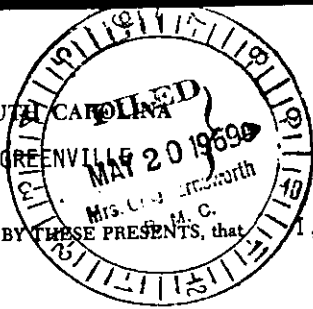

All that piece, parcel, or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as lot No. 160 on a Map of Lincoln Town, Paris, South Carolina, made by Dalton & Neves, June, 1945, recorded in the R. M. C. Office for Greenville County, in Plat Book Vol. 367 at page 387, and having according to said Map, the following metes and bounds, to wit:

BEGINNING at an iron pin on the West side of Gandy Avenue, joint corner of lots Nos. 160 and 161, and running thence with line of lot No. 161, N. 86-0 W., 150 feet to an iron pin, joint corner of lots Nos. 159 and 160; thence with line of lot No. 159, S. 86-0 E., 150 feet to an iron pin on the West side of Gandy Avenue; thence with Gandy Avenue, S. 4-00 W., 40 feet to an iron pin, the beginning corner.
