in consideration of Three Dollars, love and affection, - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Eloise B. Ellenburg and Edward Ellenburg, their Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, in the Double Springs Church community, lying on the east side of the Powell Road, and being a portion of the Tract No. 1 as shown on Plat of Property of Malissa G. Powell lands made by H. S. Brockman, Surveyor, March 20th 1930, said tract being the property of James W. Powell, said plat recorded in the office of the R. M. C. for Greenville County in Plat Book 33 at page 478, and having the following courses and distances, to wit:-

Beginning on a nail and cap in the center of the said Powell Road, joint corner of the Clifton Fowler lands, and runs thence with the Fowler line S. 52-16 E. 25 feet to an iron pin on the east bank of the road, then continueing with the same course for a total distance of 350.6 feet to an old iron pin on the former J. W. Ross land (now Fowler); thence with the line of this tract, N. 7-30 E. 123.5 feet to an iron pin, joint corner of Lester Burgess lot; thence with the line of the Lester Burgess lot, N. 52-05 W. 228.3 feet to an old iron pin; thence with another line of Lester Burgess, N. 67-50 W. 150.5 feet to a nail and cap in the center of the said road (iron pin back on line at 25 feet); thence with the said road, S. 9-20 W. 93.5 feet to the beginning corner, containing Ninety Seven One-hundredths (0.97) of one acre, more or less.
