KNOW ALL MEN BY THESE PRESENTS, that I, Nora C. Crosby,

in consideration of one (\$1.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Norman Crosby, his heirs and assigns:

An undivided one-half (1/2) interest in all that piece, parcel, or lot of land located in the State of South Carolina, County of Greenville, on the North-East side of the West Georgia Road, with the said land further shown on a plat prepared by C. O. Riddle, Registered Land Surveyor, designated as property of Ansel Kellett, and dated August 1968, and to recorded. According to the said plat, the land herein conveyed as the following courses and distances:

BEGINNING, at an iron pin on the West Georgia Road, joint corner of property owned by the grantor and Thomas Holcombe and thence, N. 38-01 W., and 286 feet to an iron pin; thence N. 48-43 E. and 479.1 feet to an iron pin; thence S. 85-00 E. and 253 4/10 feet to an iron pin; and thence S. 40-02 W. and 678.4 feet to the point of beginning. The tract contains 3.19 acres.

This is the same property conveyed to the grantor by deed of Ansel Kellett, dated September 14, 1968, and recorded at the RMC Office, Greenville County, Book of Deeds 852, page 349. This deed is prepared and executed to correct a deed between the parties hereto, dated July 11, 1969, recording Deed Book 872, page 338.
