AN UNDIVIDED ONE-FIFTH (1/5) interest in and to all that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 4 of Harcourt, as shown on plat recorded in Plat Book F, at Page 284, and having the following metes and bounds, to-wit:
