KNOW ALL MEN BY THESE PRESENTS, that We, Lamont V. Stokes and Birdie Campbell Stokes

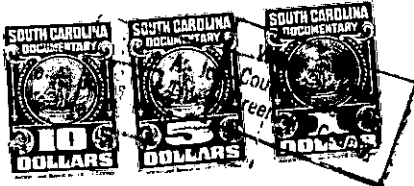
